On 01 April 2026, the People's Court of Area 1 – Hanoi accepted for adjudication Business and Commercial Case No. 44/2026/TLST-KDTM regarding a “Dispute over Ownership of Shares”.

According to the Statement of Claim filed by Petroleum Real Estate Joint Stock Company (formerly known as Viet Property Investment Joint Stock Company), the Plaintiff requests the Court to resolve the following matters:

1. To declare the Asset Sale Contract arising from the judgment-enforcement auction dated 28 November 2019 entered into between New Viet Korean Investment Joint Stock Company and the Hanoi Civil Judgment Enforcement Office null and void due to its violation of statutory prohibitions.



2. To order the recovery of all 11,850,000 shares of Petroleum Telecom Land Joint Stock Company, which are lawfully owned by Viet Property Investment Joint Stock Company and are currently being unlawfully possessed by New Viet Korean Investment Joint Stock Company.

3. To transfer all 11,850,000 shares of Petroleum Telecom Land Joint Stock Company to the Hanoi Civil Judgment Enforcement Office for handling in accordance with the provisions of law.

4. To declare that the auction deposit paid by New Viet Korean Investment Joint Stock Company in the amount of VND 6,193,646,224 shall belong to the State budget, and to order New Viet Korean Investment Joint Stock Company to repay the amount of VND 6,193,646,224.

5. To order Petroleum Telecom Land Joint Stock Company to amend its enterprise registration records and shareholder register to reflect that Viet Property Investment Joint Stock Company owns 11,850,000 shares.

The case has been accepted under the ordinary procedure.
